Great Dane sits on intruder, holds him down for deputies

Woman and her husband foiled what appeared to be burglary attempt in their home with help of dog, officials say.

LADERA RANCH – An intruder in a couple's home early this morning may have been out to find some loot, but instead he was met with a crutch, a baseball bat – and a Great Dane, which held him down until deputies arrived, authorities said.

When the Ladera Ranch couple discovered a man inside their home, they didn't have handcuffs to hold him down. Instead, their 180-pound pet sat on the man and kept him down for deputies, said Lt. Ted Boyne of the Orange County Sheriff's Department.

The incident began at about 2 a.m. today on Thornhill Street, when the woman went into the living room of the home and found 22-year-old Zachary Chanoski, Boyne said. The woman screamed, prompting her husband to make his way there.

The husband had recently undergone surgery on his leg and was in a cast. He used a crutch to walk to the living room, and when he saw Chanoski, he used his crutch to take him down, Boyne said.

His wife then grabbed a baseball bat and helped her husband, he said.

"Then Marmaduke sat on him," Boyne said.

The large dog was able to hold down the man with his weight until deputies arrived to take him into custody. Firefighters responded to the home to treat the burglar for minor cuts and bruises, Boyne said.




