After his debut weekend where he took a Reserve Major from the 6-9 class, Scout later won 4 Division IX Majors in just over 5 months in 2008, including a GDCC Specialty and back-to-back Majors. Along the way he picked up 2 more Reserves, including another Reserve to a Major. As a Special, Scout didn't miss a beat, coming out strong and regularly defeating Top 20 dogs en route to becoming the Top Club Dog for 2009. In Breed, he never won anything by default.
