

What do you need from you??? YOUR SUPPORT AND HELP!!!







Big Dog Corner

The Illusive Diagnosis and Alternative Treatment

As most of you know it is not easy to outrun a Great Dane and that was my first clue that something wasn't right. It began with me being able to run faster than Huey, his stride was off and some days I felt as though I was dragging him around the ring. I blamed the heat of the day, later afternoon show times and even wondered if he didn't want to be there. This went on for months. I dismissed that thought that Huey didn't like to show because he always raced to the car and jumped in when it was time to head for the shows and he was always excited when we arrived. Huey's appetite was sporadic, some days he would eat whatever I put in front of him but more often he didn't care much about food. On April 3rd Huey began showing signs of lethargy and within an hour he was so lethargic he had difficulty holding up his head, and walking across the yard, he also began to exhibit a slight limp. Huey soon began to shiver uncontrollably with a fever of 104.3. Off to emergency we went!

After the veterinarian's examination there was nothing specific that could be determined, no respiratory issues, no vomiting, no diarrhea, and abdominal noises were normal. With the lack of specific symptoms it was determined that Huey had a virus; he was given a shot to reduce his fever and sent home. Huey's temperature returned to normal, his appetite was better but still not where it should be and his stride was still off in the ring.

Have you ever had one of those nights that you can't sleep because your dog's tummy is so noisy it keeps you up? Due to Huey's continued lack of appetite and noisy tummy we were again off to a different veterinarian seven days after the first visit, this time due to loud intestinal noises. The veterinarian performed an ultrasound, when the results were received the veterinarian delivered the diagnosis of a prostatic cyst the size of a plum and the words an owner of a show dog never wants to hear, "Huey needs to be neutered". After asking if this was an emergency life threatening issue and being told no, I thanked the veterinarian and took Huey home.

Twelve days later we were able to see our veterinarian who specializes in reproduction, and shows and breeds her own dogs. After her rectal exam and analysis of Huey's semen, she concluded that Huey's prostate was also enlarged with a strep infection in his semen. I asked if neutering was necessary, she advised me in Huey's case that would be a last resort. She then prescribed a 30 day regiment of antibiotics (Baytril 136mg) twice daily, testosterone reduction (Finasteride 10mg) daily, and Metacam (7.5mg) daily. Three weeks later Huey's semen count was normal, his appetite had returned, he was gaining weight (almost too much) his stride was normal and I was now having difficulty keeping up with him in the ring.

My veterinarian has had several successful outcomes using this treatment and some dogs have no reoccurrence of prostatitis for years. There is not a complete understanding of what brings on this illness; however, it is known that it is more common in larger breeds than in small breeds and is thought that in some dogs, hormone level increases brought on by exposure to bitches in heat can cause this.

In Huey's case he suffered another bout eight months later and he has again responded well to this treatment with semen counts, appetite, weight, and stride returning to normal. Although this may not be the preferred treatment for everyone and in Huey's case was not a permanent cure it did provide us the opportunity to complete a very successful show year.

I hope sharing Huey's and my experience with everyone may help in early diagnosis and treatment for others.

Acting Responsibly

Sometimes I think we lose sight of the real purpose of our association with dogs and the dog world. Many people in their rush to buy, show and breed never really learn the true meaning of their responsibility to dogs. We become so bound up in the political moves of the dog world, in what dogs can do for us, that we forget that we are actually supposed to be doing something for dogs.

Whether or not you belong to a club, keep in mind your personal responsibility to your breed. This means giving the very best home to your own dog and using your influence on others to do the same. If you are contemplating breeding, don't, unless you feel your dog will make a positive contribution to the breed. All too often people, in their effort to become recognized, feel that if they breed this will somehow establish them as a breeder and bring them prestige. Breeding does not make a breeder.

Responsibility Of The Club:

The primary function of the club are protection of dogs and education of the membership and general public. The all-breed club attempts to educate its members in all aspects of dogs and to make them well-rounded members of the dog world. The breed club has its responsibility in education of its members and non-members in the breed, but should not lose sight of the fact that some members of breed clubs are lacking in all-around education. Therefore, this need should not be ignored in planning club programs.

Responsibility Of The Board:

The Board's responsibility is to further the objectives of the club as outlined in the by-laws. In striving for this goal, the board must not lose sight of the needs and desires of the membership. Since these needs are continually evolving and changing, it is especially important that board members avoid isolating themselves. They must not lose sight of the fact

that they are the elected representatives of the membership and, therefore, answerable to the membership. Since the membership supports the club from dues and other fundraising efforts, they should have a voice in how their money is used.

Responsibilities Of The Members:

The members work for the club. What is the point of club membership if it is not to make a contribution to the club and to the world of dogs. When you contemplate joining a club, it should be with the realization that you are going to work. All too often people join a club for prestige of membership. Usually, these people are not workers but are looking for their own advancement through office. In our own all-breed club, no person is considered for board membership without

having proved themselves as a hard worker, someone with good ideas and one who will have a positive influence on the membership. Consequently, our board and members are extremely productive. The membership should give strong support to the board as long as the board acts in the best interest of the members.

Breed clubs can be very productive, even with their geographical spread, if they have the leadership with the vision to understand how this can work for them.

If you are currently a member of any club, ask yourself what you can do for that club. Possibly start a program in your area that involves club members and educates both members and non-members.

If you are currently serving on a board, ask yourself what contribution you are making to that club and to the world of dogs. If you are not contributing, why are you serving?

If you are asked to serve on a board, don't accept unless you can make a positive contribution.

There are always programs to be started and worked on in clubs. Those that are creative and productive may initiate them but they need the assistance of helpers and contributors. Make a contribution to the world of dogs by recognizing your abilities and acting accordingly. Don't accept a job you cannot do which can only result in damage to your club.

If you act responsibly and do the best you can, at the end of the year, you should look back and be able to cite at least one contribution you have made to the world of dogs, and that's what it's all about.

Launched in 1989, Canine Good Citizen is an AKC certification program that rewards dogs with good behavior both at home and in the community. Testing is a ten (10) part test that requires passing <u>all</u> ten (10) parts to obtain CGC Award:

1.	Accepting a friendly stranger	6.	Sit and down on command and Staying in place
2.	Sitting politely for petting	7.	Coming when called
3.	Appearance and grooming	8.	Reaction to another dog
4.	Out for a walk (walking on a loose lead)	9.	Reaction to distraction
5.	Walking through a crowd	10.	Supervised separation

Additional Information

Dogs must be on leash when performing tests. Well-fitting buckle or slip collars made of leather, fabric, or chain, should be worn by dogs. Pinch collars, head halters, and other special training collars are not permitted in the CGC test. A 20' lead for the test will be provided by the evaluator. The dog's brush or comb should be brought to the test by the owner/handler. Owners/handlers may praise and use encouragement throughout the test. The owner may pet the dog between exercises. Treats and food are not allowed during testing, neither are toys, squeaky toys, etc. Upon passing, owners/handlers will be provided with the proper documents to submit to the AKC for CGC registration. Any applicable AKC fees are the responsibility of the owner/handler. Dogs that eliminate during testing will be marked failed. There is an exception to this rule in that elimination is allowable in test Item 10, when test Item 10 is held outdoors.


